4. Finance

- **4.1 Finance Papers & Update** ON provided an update and noted that the Finance Committee met on Wednesday with PW, LT, JI and ON in attendance. 25/02/19 Aged Payables, Balance Sheet, Profit and Loss budget analysis and Aged Receivables were circulated. The Aged Receivables and Payables are of no concern and a few calls to be made at the beginning of March further to a similar timing of payments as per some previous quarters. It was noted if no response by those members whose quarterly payments are in 90+ days that letters will need to be issued.
 - LT moved that the Finance update be accepted and BR seconded.
- 4.2 Grants Update Focusing on the delivery of the Mixed Dozen and we will share the schedule of time commitment and noted that Project 250 funding submission submitted by ON during leave on 18 February 2019. CV funds of \$5k committed further to Treasurer approval prior to ON leave and based on budget position.
 - EMDG meeting held with Stuart Mitchell on 25 February 2019 note there is potential to claim for Vinexpo. Action tracked in outstanding action items.
 - Clarified that SATC \$15k committed per year for three years and in place for CCC 2019 and CCC 2020.

5. Correspondence & Communication

- **5.1** Nick McBride acknowledgment AF letter dated 10 January 2019 CV to follow up with office. PMN: ON contacted Jennifer Schilling and it was believed that Lucindale Naracoorte Council were discussing this week and once a position was reached that further action will follow and CV will be informed of next steps. We will await this information.
- **5.2 Groundwater Innovation Correspondence** Awaiting the letter that is being prepared as a variation to VOC scope based on the WAP needs of the region.
- **5.3 Container Deposit Scheme** SAWIA noted there is a process in place for feedback and responding on behalf of SA wine industry. CV to have a policy in accordance with SAWIA. Discussed the plan to include wine bottles in the scheme at \$0.10. We will continue to monitor the situation.
- **5.4 Rob Geddes Coonawarra China Education** Noted verbally that Rob Geddes reached out in Feb and we responded with the link to the WA Education document and that we can now review our education provision as we have a document available via WA's website: https://www.wineaustralia.com/education/coonawarra.

6. Brand Reference Group (BRG) now Brand Reference Committee (formerly Marketing Committee)

6.1 Update ON highlighted the membership as per the Agenda includes Joy Bowen, Sue Hodder, Dru Reschke and Erin Fields and that we can open a call for further two members to join. From a branding perspective the Brand Document is a key deliverable as is building partnerships to realise remaining and ongoing CBAP actions. It was noted in the meeting and in the January meeting the need to share the Coonawarra story and current regional status. A list of influencers and contacts and relationship owner are to be profiled for stakeholder management.



7. Viticultural and Oenology Committee (VOC) Report

7.1 VOC Update

SM provided a VOC Update further to discussion with transitioning Chair CK highlighting the following two actions:

- A letter is to be drafted regarding the capacity of resources and board members of SENRM. For example the number of groundwater hydrologists in our area for water testing. The CV is keen to better understand the succession plan for the loss of this expertise.
- 2. How will CV respond to the outcomes of the Goyder Review and inconsistencies in the data capture?

ON noted that the ideas raised at the last Board Meeting proposed for CV to advance greater awareness through our existing networks are to be allocated to respective workstreams for office to track – note that the next VOC Meeting is April and BRG meets on 13 March and this plan can be presented at this time:

- Third party endorsement to assist with promotion and reach at events or meetings. Topics that could be discussed
 include: What has changed over the last 20 years? Proposed that each member could share five bullet points that we as
 an Association can collate.
- Webinars and transferable nature of the outcomes and ASVO.
- Wine Show and judges' briefings and ongoing dialogue on all the positive stuff that we are doing.
- Winemaking and journalists to be briefed. Personal calls from within the region.
- Board to profile the patrons, brainstorm contributors or icon bios for example Distinguished Coonawarra Identity such as Allen Jenkins.
- **7.2 Draft Coonawarra Vignerons Project Partnership Update** Not discussed noting it is on hold and looking at reactivating partnerships as we plan for the 2019/20 Budget.
- **7.3 Water** –. PB noted next week looking at the risk assessment and may not achieve the dates. Nominated Nikki Harrington and Glenn Harrington are heavily involved and further to discussion during attendance in region that further involvement would be sought to increase the dialogue with Ministerial level on the water allocation plan. Further information to follow.
- **7.4 Fracking** Position statement remains unchanged. PB advised in January that the CSIRO contracted by Government to interview Stuart Sharman, Pete Bissell and Pete Balnaves re fracking. PB updated that he received a South east Mud Management update and it was to be forwarded to ON for circulation to the Board with these minutes.

8. Industry Engagement

8.1 ON provided an update on industry (SAWIA, PIRSA, SATC, RDALC, Wattle Range Council, Tourism Mount Gambier, Brand SA and other Regions) relationships noting that since the last Board Meeting there has been three working days. Discussed the following in detail and raised the need to maintain communication with Robe:

- SAWIA and whether CV should be a member as an Association. It was acknowledged that we paid for the governance review that was undertaken and this approach will be taken moving forward acknowledging that the regional relationship also provides SAWIA's access to the region. CV to consider how we can advocate SAWIA membership acknowledging their value.
- Wine Australia Education document is online, see link: https://www.wineaustralia.com/education/coonawarra.
- Tourism Mount Gambier JB suggested reaching out to leverage of their signage review and any helpful hints if we pursue historical markers.

9. CV Executive Officer Activity Report

9.1 EO Verbal Update provided in conjunction with Board reporting. PMN: As reported in January, Social Media AOK Consulting (Account Manager Tamara Caire tamara@socialmediaaok.com.au is assisting with Social Media. ON is reviewing the March content schedule that they shared on Monday 25 February 2019 to provide feedback and noted that AOK are not undertaking reactive reposting and monitoring rather scheduling content posts. Heidi may continue assisting with 3 to 5 hours assistance per week for monitoring and website event calendar and article posting.

9.2 Cellar Door Event Committee to meet focus on the Coonawarra Visit and Bus Policy and then progress to Board if in agreement. Manual is also to be finalised for reissue. All events have called for member participation and registration for response end of Feb for materials to be prepared and printed in March. **Roadshow Committee** dates are finalised and communicated to Members with additional uploads to website in advance of dates to be communicated publicly with announcements in March. Roadshow Committee to consider the Tour Operator feedback and provide a recommendation to Board for review in our March Meeting – noted that Budget will be shared at the next meeting based on the venue costs. **Cup Committee** debriefed at Kidman Wines on 25 January 2019 and noted need to review the provision of AC as per outsourcing of the marquee installation. Noted that feedback also provided by Cup Committee seeking greater pack down by Comedy in Coonawarra event. Member and Sponsor feedback provided since 25 January 2019 will be consolidated and provided to the Cup Committee for their review in April – note as we were still consolidating the P&L this was not reviewed in



the January meeting and it will be shared.

10. Welfare, Health and Safety (WHS)

- 10.1 Update Nil issues.
- 10.2 Risk Planning Insurance details have been provided to Board for a common understanding of our coverage. We will review these and seek SAWIA review also to ensure we are adequately covered. We noted also that we will look into international coverage noting that travel insurance is in place, however we do need to verify if anything further should be in place as an Association.

11. Membership

11.1 Membership update – Noted change of Kidman Wines to Base Membership increasing our Grapegrower membership to 13 and with 33 P&E members our total membership of 46 – TBC following renewals. Coonawarra Vignerons Membership Renewal Form reflecting the change from LCGWC AGM of increase from \$0.77 to \$2.00 was issued end of Jan for return in Feb. It was noted that the list of members will be shared with the Board when finalised and at present we have received responses from 19 members. ON raised that it may be an option to consider opting out rather than opting in, noting that our need to share forms this year was to also verify vineyard size and contact details.

12. New Business

- **12.1** GM Policy to be prepared and not we are consistent with Wine Australia GM Free.
- **12.2** TG identified Ian Botham as a potential spokesperson partnership given the recent interview and favourable commentary in the James Halliday Magazine.
- **12.3** Early vintage report Discussed that we are experiencing two vintages at play at the moment. Those that received winter rain and those that have had water to irrigate during the heat. It was agreed that a short summary is to be prepared for website and membership circulation.

On this day Thursday 17 January 2019, Pete Balnaves was proud to induct two new patrons,



Q8 How are conflict of interests managed at the Board meetings?







Hi again

I have received a response from EPA as below. I have a few questions that I have discussed with Daniel, and will follow with an email. He indicated that he may need to refer it on to another person in the EPA that deals specifically with waste handling. The response has raised a few more questions from me, and please let me know if you have any other questions.

My questions relate to the highlighted text and are:

- Who engaged the site contamination auditor? (Possibly Resource Co according to Daniel).
- What was the actual 'classification' assigned by the site contamination auditor as a result of the review?
- What is the nature of the disposal site (i.e. rehabilitation site)? Is it supervised by the same site contamination auditor that conducted the review?
- What are the EPA's processes for oversight, or accreditation, of the site contamination auditors to verify, validate or audit decisions and actions made on the basis of their findings?

Hi Mark,

Just a follow up to your questions last week regarding the drill material taken from the South East to the McLaren Vale facility, we have complied a summary below. Once you have had a look and considered, please let me know if you have any further questions:

Beach Energy drill cuttings

- In 2018 approximately 2700 tonnes of drill spoils (the muds which are brought to the surface
 during the drilling process) was transported to the Southern Waste ResourceCo McLaren Vale
 waste depot. The depot is licensed by the EPA (EPA 32682) to receive waste soil according to
 the following classifications Waste Fill, Intermediate Waste Soil, Low Level Contaminated Soil
 and High Level Contaminated Soil. The material in question produced by Beach Energy was
 received as a spadeable soil.
- Prior to being transported to the McLaren Vale waste depot, some initial testing was conducted
 at the drill site indicating the material was of an 'intermediate waste classification' with limited
 testing

- Upon receipt of the material, Southern Waste ResourceCo engaged Mud Environmental to undertake re-testing and assessment on the physical and chemical composition of the material as the material must be properly characterised before any end use is executed.
- Site contamination auditor, Phillip Hitchcock was then engaged to conduct a review of the test results completed by Mud Environmental to determine potential reuse of the material as fill. The assessment looks at aspects such as the chemical composition, ability for any contaminants to leach from the material and based on this categorises the material which then guides or limits how the material may be used. This included consideration of metals that there are no criteria for intermediate waste soil such as barium.
- The review concluded that the material was suitable for reuse and rehabilitation at the former Tatachilla Sand Quarry located at 473 Tatachilla Road, Tatachilla SA (audit site). This site is not licensed by the EPA but is under the supervision of a site contamination auditor.
- The drilling mud results from Haselgrove-3 were uploaded to the EPA website. I believe you have a link but provide it just in case it is needed https://www.epa.sa.gov.au/business_and_industry/industry-updates/beach-energy
- On the basis of the endorsement provided by the site contamination auditor, Southern Waste ResourceCo then moved the material to the audit site, which is adjacent to the waste depot.
 The material was placed 15 meters below the surface and the EPA understands Southern Waste ResourceCo intend to raise to level of the pit to the natural land surface.
- If it were the case that the material was classified as low level contaminated waste or High level contaminated waste, Southern Waste ResourceCo would have been required to execute a different management strategy, commensurate with the nature of the material which may have included further treatment of the material and deposition in a dedicated lined facility.

I have followed up with EPA and Anne Daw about the disposal of drill spoils from Haselgrove 3.

See below for EPA's undertaking to get back to us.

There is also a report on the testing and recommendations for disposal available from the EPA at: https://www.epa.sa.gov.au/business_and_industry/industry-updates/beach-energy. The report summary suggests to me that they considered it met "Intermediate" level waste criteria and so could be used as "waste derived fill" (i.e. dumped in an unlined quarry), which still needed approval from EPA. Anne Daw expressed some concerns about possible limitations with the sampling and testing.



Was there a defining moment that made you fall in love with wine?

No, but there was a defining person – John Arlott. He was a cricket commentator, raconteur and the only man the French would allow at that time to write about their food and wine. I got to know him very well and he introduced me to wine at the age of 17 or 18. Every morning, copious amounts of wine would arrive from France and my job was to get it into his cellar and bring back whatever he wanted to try that day in a wicker basket. I was just a young kid doing the sporting thing and didn't have a clue about wine, but that's when I started to understand it.

Were there many great wine discoveries while touring during your cricket career? Loads! I remember coming to Adelaide and saying, 'Blimey, I don't like the beer here!' I was with [fellow former cricketer] Bob Willis and [winemaker] Geoff Merrill, who said, 'Well, if you don't like our beer, you may as well try our wine!' That was 40-odd years ago. I've since gotten to know many winemakers out of South Australia and always been really interested in the wine.

And now you're making wine here. Did you ever imagine that?

I always knew I wanted to work with wine in one way or another, but a year ago, I wouldn't have known what to do in a blending room. Now I love experimenting. What I've tried to do with the range is produce wines that I'd put on my table, regardless of company.

Did you have any wine traditions for celebrating the big cricket wins?

I don't think we were too bothered – we'd drink anything! Although, there were about six of us on the team who would rather go to a nice restaurant and drink a good bottle of something, while the others would go to the pub and drink beer. But gradually everyone enjoyed wine.

Do you have a wine collection?

I'm actually running it down because we're moving into a modern home. Where we are now, the house dates back to 1570, so the cellar is well established. I'll put the expensive wines into storage and I'm looking for new wines to put into the new cellar. But right now, I'm really enjoying drinking wines that I sourced 15 or 20 years ago.

What can you tell us about the wines in your collection?

I'd say the majority of my wines are from Australia, with quite a lot of pinot noir from New Zealand and some very good Riojas from Spain. Have you had any cellaring disasters? No, touch wood! I certainly know of a few, but luckily I haven't had any personally.

What wines are you loving right now? It depends on what I'm doing. If I've just tasted 200 pinots, I'm likely to have a G&T or anything but wine. My favourites are chardonnay, because it's such a wonderful grape and you can do so much with it, pinot noir and also cabernet, particularly from Coonawarra. For me, Coonawarra cabernet is the real symbol of Australian red wine.

Any favourite wine regions to explore? I've never gotten bored in a wine region. I'm doing a lot of travel these days for the range, so I'm looking forward to getting to Argentina. I also love going to Spain – they have some fantastic reds.

Is there any wine you can't learn to love? I get a bit of brain-fade with sauvignon blanc. I'm afraid I don't get it. I find it acidic, minerally and like fresh-cut grass – I get hayfever from it!

Any favourite food and wine experiences? I've been friends with [chef] Michel Roux for a long time, so if I'm in England, I love going to [his venue] The Waterside Inn. When I'm in Australia, I love Georges on Waymouth in Adelaide.

What's your all-time favourite food and wine match?

I don't really have one. I love good oysters with chardonnay, but I'm a great believer in not only having white wine with white meat. If you're having a pork chop, I don't see why you shouldn't drink what you want with it.

What's the oldest wine you've tried?
I've got a double magnum of Port in my
cellar, which dates back to the 1800s. Only
12 of them were made and only six have
been traced. I don't really drink Port, but
that's about as good it gets. I have to make
sure the grandchildren don't get their hands
on that one.

Any favourite bargain wines?

You find some great ones in Spain because there's no tax on wine. You can to go the supermarkets and pick up a 1996 Gran Reserva for 15 euros, so it's always worth looking if you're there.

Do you miss cricket?

You move on. What's the point in missing it? I really am enjoying this stage of my life, especially working in wine. There's definitely life after cricket! ●
