## 2. 110km speed limit during vintage and whether as an Association we need adopt a position (Board Pack Reference New Business)

Following a round table discussion it was confirmed that a position statement is to be prepared and shared with members as follows:

The Coonawarra Vignerons agree that 110kmph zone is a high risk and support an 80 to 90 kmph rezoning. This is a long held position and has lobbied to decrease the speed limit as the interaction with tourist and vintage traffic is a dangerous mix.

It was also noted if questioned re the bypass, the position is as follows:

The bypass has gone through due process with landholders compensated for what they have lost.
